TOPIC & PURPOSE:

The report reviews the total statistics related to calls for service responded to by police service members. This public report is to keep informed our community and the Prince Albert Board of Police Commissioners on statistics and service requirements for September and the year to date for 2021.

BACKGROUND:

Monthly statistics related to police calls for service are captured, reviewed and released to the Board and public. The statistics captured in this report are measured and compared to the previous year, and in some cases, a five-year comparative review is provided to identify anomalies or trends to monitor and determine effective and efficient deployment of all police resources. The report will also capture the specific monthly data for September 2021.

PROPOSED APPROACH AND RATIONALE:

Total Calls for Service Five-Year Trend:

The all calls created and attended to by the Prince Albert Police Service members to the end of September 2021 was 34,284, which was a 2.27% decrease over the previous year. The calls captured in the total amount include a 1.75% decrease in proactive "neighbourhood

strengthening" efforts, which is a proactive patrol and attendance that has been recorded by a member to capture a general patrol effort or specific response to an area of focus.


The total calls responded to by members of the police service in September 2021 after taking out proactive calls for service – including neighbourhood strengthening, COVID compliance, and court conditions – was 30,701 and that is a decrease of 2.53% over the previous year. The following graphical representation provides the five-year total call trends for all calls and dispatched calls.



Appendix 1: a visual representation that shows the calls for service over the previous five (5) years.

The total police activity, including proactive high-visibility patrols in the month of September was 4,118 and that represents 269 more than the previous year. The five-year September average for all calls is 3,756.


Calls for service in September was higher than the previous year by 6.58% with 3,774 calls compared to 3,541 in 2020.

Violent Crime:


The Prince Albert Police Service responded to 867 victims of violent crime (YTD) in 2021, which represents a 6.87% decrease from the previous year of 931. The five-year average was 861 reported (YTD).



Appendix 3: a visual that shows the total number of victims of violent crime over the previous five years YTD.


The victims of violent crimes in September 2021 involved 106 victims, which represents two (2) more victims than the previous year. The September average of victims of violent crime is 92.

This year shows a 15.2% higher victim rate than the average.




Appendix 4: a visual representation that shows September 2021 for total number of victims of violent crime reports and the five-year comparison.

Total victims of sexual violations reported and investigated in 2021 was 94, an increase of 1.08% over the previous year when 93 victims reported. The five-year average incidents reported of sexual violations is 81.

The September total victims of sexual violations reported was three (3) and that represents a lower-than-five-year average of six (6) and significantly lower than the previous year when seven (7) victims reported.




Appendix 6: a visual representation that shows the month of September and five-year average of sexual violations reported.

Reported Assaults

The Prince Albert Police Service responded to 573 victims of assault complaints YTD in 2021 and that represents 11.02% fewer victims than the previous year, when there were 644 victims of assault YTD.


The top three (3) assault types make up 87% of the victims of assaults



Appendix 7: depicts the number of victim of the top three (3) assault types and the corresponding number of assault files with charges.


Robbery

The total robbery complaints YTD in 2021 were 63 incidents and that represents 18.18% fewer robberies than the five-year average of 77 incidents YTD.

The average robbery complaints in the month of September over the past five years has been nine (9) incidents. In September 2021, we observed 14 incidents of robbery.




Appendix 9: represents the five-year total robbery complaints for the month of September.

Property Crime:


The Prince Albert Police Service has responded to a higher amount of reported crimes against property YTD. The total reports of property crime was 2,568 incidents and that represents 27.82% more incidents than 2020, when 2009 complaints had been reported.

The top five YTD property crimes reported have been; willful damage, theft under, shoplifting, theft from vehicle and theft of motor vehicle.




Appendix 10: represents the 2021 top five property crime incidents compared to 2020.

The YTD average for crimes against property for the past five years is 2513 events with 2568 reported YTD 2021. This is an increase of 2.2% more property crime reported this year when compared to the 5-year average.

Significantly lower-than-average property offences were observed in the month of September with 226 offences compared to the five-year average of 285.

The Prince Albert Police Service in September responded to the same number of suspicious fire incidents as the previous year in September with six (6) incidents.




Appendix 13: a visual representation that illustrates the YTD to September arsons and the type of incident.

Break and Enters

The five-year average for break and enters is separated into types of property to include a residential property, outbuilding and commercial or non-residential, and break and enter to steal firearms. The offences of break and enter reported in 2021 was lower in related properties with a decrease of 3.60%.

Break and Enters during the month of September alone were less than in previous years. The total incidents were 27, a 64% decrease from September 2020.




Appendix 15: a visual representation that illustrates the five-year total Break and Enter complaints for the month of September.

Theft of Motor Vehicles:

The Prince Albert Police Service saw a 55.31% increase in reported theft of motor vehicles YTD in 2021. The total number of stolen vehicles was 278 compared to 179 the year prior. Of these, 55 have charges attached, involving either theft of vehicle or possession of stolen vehicle.

The charge clearance rate for stolen vehicles is 19.78%. Many vehicles were stolen using the key or fob and 70 vehicles had keys reported to be left in the vehicle. In 188 files, the doors were left unlocked.






Appendix 16/17: a visual representation of keys left in vehicles and stolen/recoveries/charges.

Firearms Seizures:

The total number of seized firearms this YTD was slightly higher with 108 seizures. The previous five-year average is 98 seizures. The five-year average for weapon charges is reflected this YTD with the total of 85.




Appendix 19: a visual representation of the different types of firearms seized in 2021.

Appendix 21: a visual representation of firearms brandished or discharged year to date to end of September.


Firearm Amnesty

As recommended by the Board of Police Commissioners at the September meeting, a local firearm amnesty program has been launched to invite our public to relinquish firearms to prevent unlawful use or access. The provincial amnesty program is scheduled to run in the spring of 2022.

Controlled Drugs and Substances:


The Prince Albert Police Service has multi-level response to drug trafficking including the general enforcement by front-line uniformed members complimenting the focused enforcement that is carried out by the Street Enforcement Unit and Integrated Crime Reduction Team. Early education delivered by all members and specifically the Community Policing Unit is a critical component to addressing the harms that drug addiction has on our community.

In 2021, the enforcement of drug trafficking contributed to many of the seized firearms and led to September drug trafficking offences with 29 possession offences and 51 trafficking offenses. The trafficking events in 2021 is 18.6% higher than the five-year average of 43.

Drug trafficking and possession in September alone is lower at three (3) than the five-year average of six (6).



Appendix 23: illustrates the September drug enforcement for the past five years.


The top drug types that were seized in 2021 include; methamphetamine, cocaine, crack cocaine, crystal methamphetamine and cannabis resin. During the year, the greatest seizures by both weight and occurrence included the methamphetamine seizures of 175 and the 45 seizures of cocaine.



Appendix 24: illustrates the five different drug types, number of seizures and weight by gram.


Arrests:

The total arrests that occurred in 2021 has been 4,308 for both charge-related offences and general intoxication. This represents 123 fewer arrests than 2020 when 4,431 total arrests occurred YTD.

The arrests that occurred in September further represented the trend seen throughout the year of fewer people arrested with more diversions from custody related to both charge arrest and intoxication.

Ticket violations related seen an overall 6.45% decrease from the previous year with 6,988 total offences compared to the 7,470 observed in the previous year.



Patrol Support:

The unit attended 57 calls for service related to non-emergent criminal offences throughout the month.
